- 4) Attend one Joint Policy hearing and be prepared to offer to clarify, amend or support proposals at the hearing. Report to the Section at its business meeting about the policies discussed.
- 5) Develop an Op-Ed or letter to the editor with assistance of a Medical Care mentor or prepare a news report for APHA The Nation's Health or prepare a Medical Care blog post.
- 6) Participate in major Medical Care sponsored sessions at the annual meeting including: Evening with TBD (Tuesday night); at least one contributed paper session and the student award session (Tuesday afternoon).
- 7) Observe a Governing Council session.
- 8) Meet with APHA's Public Health Congressional fellow.
- 9) Be an Active medical care section member September 2019 through June 2020 by attending monthly Medical Care Section calls, interacting with section leadership, assisting Medical Care Section chair, chair elect, and secretary as requested.

Covered expenses include:

- 1) Transportation to and from the meeting venue
- 2) Meeting registration and APHA membership

Excluded expenses: hotel, food and incidentals
